Divisions, Racing Schedule and Format

Divisions and Racing Schedule will be posted on the Region 19 website www.region19flyball.com and www.denverspeeddemons.com

1 point will be awarded for each heat won. For any tied heat each team will receive 1 point. For tournament placement ties: fastest legal time in head to head competition between the tied teams wins, if still tied fastest legal time of the day wins. If 3 or more teams are tied fastest legal times of the day will determine placements for tied teams.

Line and Box Judging

We have assigned judging by club, the more teams entered the more judging your club is responsible for. Please be ready to fill chairs when assigned to help the racing move along. There are conflicts, we will wait for you to get your dog if you have just left a judging chair to start warmup, please communicate with judges when you are leaving the chair to get your dog(s). The worker's raffle will be near the racing ring, please don't forget to fill out your tickets and enter! For questions and concerns please see Tara Crase.

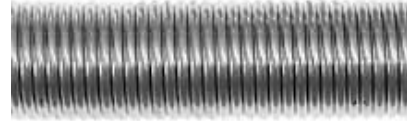
